1. Call to Order and Roll Call at 6:30 PM

2. Adoption of meeting's Agenda

3. Approval of Minutes for prior October 24th Board Meeting

Approved with no changes.

4. Perimeter Land Management – Don Shannon chair

- a. Cascade Landscaping first cleaned the West side of Shute Road, then Red Bark Inc laid down 1" depth of bark dust. This will protect the landscape until the City of Hillsboro begins their Bike lane project.
- b. This week Cascade will 'mow down' the St Johns plants on Cornell Road; this will allow better growth in Spring.

5. Architectural Review Committee (ARC) – submitted by Laurie Anderson chair

- a. This has been a slower month for projects. The ARC has approved a fence replacement and a gutter repair.
- b. Noise late at night (loud music and raised voices), after 10:00pm is still the number 1 complaint. There are 3 homes on the East side that are repeat offenders. This is a violation of a Hillsboro Ordinance (police have been called) and HFVOA rules (Blue Mountain can be called to cite a nuisance violation).

6. Treasurer – Sharon Stiffler

- a. A review of the invoices and payment of expenses made through Blue Mountain shows that expenses are on track with the approved fiscal year budget.
- b. On November 22nd Blue Mountain posted September 30th Financials instead of the October 31st Financials. Blue Mountain had already posted the September 30th financials on October 24, 2023. This matter has been addressed with BMCM.
